All activities relate to enhancing the ability and efficiency of the food bank members to solicit and distribute food and grocery products for those in need. Our Farm to Food Bank program provided over 46 million pounds of produce to our food banks to distribute to those in need. Feeding the Carolinas coordinated a network-wide response to the largest disaster in our network's history, Hurricane Helene, providing emergency food aid to tens of thousands of Carolinians, as well as funds for rebuilding and recovery to the charitable food network in North and South Carolina.
